of One Units (50 Intake). The institution after fulfilling all the provisions of

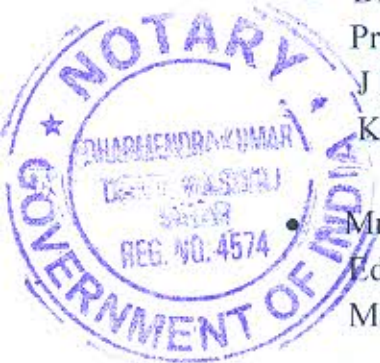

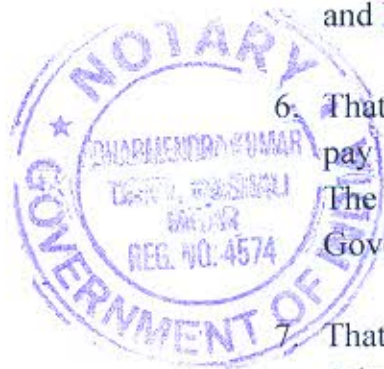


